<u>GENERAL INFORMATION</u> Rehearsals/Tryouts will be held at the Oroville State Theatre on March 15, 2022 at 4:00 p.m. Performance will be **Saturday, March 15, 2022 at 4:00 p.m. at the Oroville State Theatre.** To be eligible to compete in the program, contestants must: a) have reached their 6<sup>th</sup> birthday but not their 19<sup>th</sup> birthday by May 31, 2022; b) be enrolled in school; and c) be of amateur standing. First place winners go to the District Exchange Competition on Sat., June 11, 2022 at 2:00 p.m. Exact location to be announced. ## **RULES OF ELIGIBILITY AND PARTICIPATION**

1. Contestants must be enrolled in a public school, parochial school, private school, home study program, charter schools, or school of the arts. You may only enter one (1) Exchange Club Search For Talent Contest each year.

2. Contestants must be of amateur standing only. Any person, who participates in a professional performance or is under contract <u>through a professional agent for such appearances</u>, will not be eligible to compete. "Professional", as used in "a professional performance", denotes one undertaking or engaging for money as a means of subsistence in a particular art and is defined as meaning engaging in by professionals as a means of livelihood.

3. Contestants who are members of the immediate family of any Officer, Board Member or Director of the Sierra-Pacific District Exchange Club <u>are not eligible</u>. Immediate family members of any Exchange Club Member, Club Officer, or Club Board Member <u>are eligible</u>.

4. Contestants appearing as a "group" must not exceed four (4) persons.

5. Only one (1) musical accompanist, provided by the contestant, is permitted for each act. The accompanist is not considered part of the act for scoring.

6. Contestants are permitted **FOUR (4) MINUTES** in which to complete the act. Penalties of ten (10) points for each minute or fraction of a minute exceeding the four (4) minute time limit will be imposed by the Timekeeper. Introductory music for the contestant begins the time. Once the act begins, there will be **NO STOPPING OF THE CLOCK** for props or changes.

7. Contestants using CD's, DVD's, or MP3 for musical accompaniment cannot use a recording that predominates over the

contestant's performance. **Example:** a vocalist cannot use a recorded singer as an accompaniment and the contestant as a duet. 8 Contestants will be classified in the following performance categories:

*Note:* Baton twirling, juggling, and trampoline acts are considered "novelty" and cannot be used in any act. SWORDS, KNIVES, GUNS, PYROTECHNICS OR FIRE ARE NOT ALLOWED!

9. Contestants who will have reached their 6<sup>th</sup> birthday but not their 10<sup>th</sup> birthday by May 31<sup>st</sup> of the contest year will compete in the **PRIMARY DIVISION**.

- 10. Contestants who have reached their 10<sup>th</sup> birthday but not their 15<sup>th</sup> birthday by May 31<sup>st</sup> of the contest year will compete in the **JUNIOR DIVISION**.
- 11. Contestants who have reached their 15<sup>th</sup> birthday but not their 19<sup>th</sup> birthday by May 31<sup>st</sup> of the contest year will compete in the

## SENIOR DIVISION.

12. Contestants performing as a "group" are classified by the age of the oldest in that "group" and must compete in that Division.

13. Contestants are permitted to participate and be judged in only one act. Example: A contestant cannot be judged in a "group" then again as a "single" in a different act in that Division.

14. A First Place winner in one year can compete in the same age division in the next year if they meet certain requirements:

A. If the 1st place award was won in a "Group", the contestant must appear as a "Single".

B. If the 1<sup>st</sup> place award was won as a "Single" the contestant may appear the Following year in a "Group" or they can skip to the following year and appear with no restrictions in the following (2<sup>nd</sup>) year.

C. In all cases, a winner in one age division may appear without restrictions if the next appearance is in a higher age bracket. 15. Contestants may participate in only one Exchange Club Contest in the same year.

16. It is recommended that a contestant not compete in the Club Contest if he/she will be unable to continue as a first place winner in the District competition on **Sat.**, **June 11**, **2022 at 2:00 p.m**. Exact location to be announced.

17. The Oroville Exchange Club reserves the right to record and use performances by audio, video, and copied by any other means of recording the acts, upon receival and during the Search for Talent Contest performance, and to utilize said recordings for the purposes of promoting the Oroville Exchange Club and the Search for Talent program in the future. Contestants and their parent/s or guardian/s hereby grant Oroville Exchange Club a non-exclusive right, with or without further notice, to use, distribute, and/or sell for fundraising purposes any such recording made of the Search for Talent rehearsal or performances.
